### **JUDGING SCHEDULE**

Briefing at 8:15 Trial 1 will begin at 8:30 am. Trial 2 will follow Trial 1 but will not start before 12 noon. **Judges will take a short lunch break between trials.**

- Doors will be open at 7:15 a.m.
- Dogs may be crated in the adjoining room. Your car is easily accessed and working out of your car is an option.
- Metal Chairs are available to competitors. Feel free to bring your own chair for comfort
- Our training center accommodates a small number of spectators.
- General Briefing will occur before each trial
- Move-ups will be allowed according to CDSP Obedience Regulations between trials. **No Day Of Entries.**

**Food:** Light breakfast and coffee will be available in addition to our fabulous pot luck lunch selection. There are many fast food restaurants within 5 minutes of Tails U Win (Subway, McDonalds, Wendy's, etc). Water available for nominal cost. There is also a sit down restaurant, Adams Mill, in the same parking lot.

## Notice to Exhibitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of CDSP Competition Obedience rules and regulations including but not limited to the following rules regarding entry:

- ◆ This trial is open to dogs at least six months of age, including purebred and non-purebred, and to dogs with disabilities who are not in pain or discomfort.
- ◆ Bitches in season may not compete. Refunds will be given for bitches in season if request is accompanied by a note from the exhibitor's veterinarian.
- ◆ Dogs exhibiting signs of aggression that threaten the safety of other dogs or humans will not be allowed on the show grounds.
- ◆ All dogs must have a CDSP registration number prior to competing.
- ◆ Dogs must be shown by a member of the owner's immediate family: mother, father, spouse, life partner, sibling, child, grandparent, or grandchild.
- ◆ Safety shall be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- ◆ The organizing committee may refuse any entry for any reason.

In addition,

- ◆ THERE SHALL BE NO REFUND for entries withdrawn or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.
- ◆ Returned checks do not constitute a valid entry. There will be a \$35.00 service charge for returned checks. Payment of entry fees and service charges shall be made in cash or by money order within 30 days of postmark of notice of returned check where notification is received after event date. Any fees not received within 30 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible, and all awards must be returned within 10 days of notification or the dog's registration may be suspended pending restitution. Any unpaid fees or shortfalls must be paid prior to the start of the event, or entry is canceled without recourse by owner/handler.
- ◆ Credit card payments will not be accepted for these trials
- ◆ No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of the organizers.
- ◆ All dogs shall be shown in a flat buckle or snap collar, or properly fitted martingale (limited slip) collar. No choke collars, prong collars, shock collars, harnesses, martingale leads, or head collars are allowed.
- ◆ All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes. Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
- ◆ Dogs must be on leash while on show grounds and in the parking lot.
- ◆ Please pick up after your dog and yourself.

## A, B and C CLASSES

**Starter Novice A:** Shall be for dogs who have not earned any other obedience title in any registry and does not have a qualifying score (Q) in Novice in any obedience registry.

**Starter Novice B:** Shall be for dogs who have earned a Beginner Novice (BN) obedience title or equivalent in any registry and does not have a qualifying score (Q) in Novice in any obedience registry.

**Starter Novice C:** Shall be for dogs who have earned a CDSP Starter Novice title (SN-C) in either the A or B class and does not have a qualifying score (Q) in Novice in any obedience registry.

**Novice A:** Shall be for dogs who have not earned any other obedience title in any registry.

**Novice B:** Shall be for dogs who have earned an obedience title in any registry.

**Novice C:** Shall be for dogs who have earned a CDSP Novice title (CD-) in either the A or B class.

**Open A:** Shall be for dogs who have earned the CDSP Novice obedience title (CD-C).

**Open B:** Shall be for dogs who have earned the CDSP Novice obedience title (CD-C) and/or any other Open obedience titles in any registry.

**Open C:** Shall be for dogs who have earned a CDSP Open title (CDX-C) in either the A or B class.

**Utility A:** Shall be for dogs who have earned the CDSP Open obedience title (CDX-C).

**Utility B:** Shall be for dogs who have earned the CDSP Utility obedience title (UD-C) and who wish to earn a CDSP Utility Dog Excellent title (UDX-C) and a CDSP Obedience Trial Championship title (OTCH-C).

**Utility C:** Shall be for dogs who have earned the CDSP Utility obedience title (UD-C) and who wish to earn the CDSP Utility Championship obedience title (UD-CCH).

**Versatility A:** Shall be for dogs who have earned the CDSP Novice Championship obedience title (CD-CCH).

**Versatility B:** Shall be for dogs who have earned the CDSP Novice Championship obedience title (CD-CCH) and any other Open or Utility qualifying leg or obedience title in any registry.

**Versatility C:** Shall be for dogs who have earned a CDSP Versatility title (VT-C) in either the A or B class.

## AWARDS

A qualifying ribbon will be awarded to each team who earns a score of 170 or higher. Placement ribbons will be awarded to the four top scoring teams in each class. Rosettes will also be awarded for new titles, High in Trial and High Combined.
